PDE Information from Kerry Helm

The Acting Director of the Bureau that oversees certification and teacher preparation guidelines issued an official announcement on May 20. If you did not receive a copy through your college/university email, the full text is reprinted below:

"Dear Colleagues in Education,

On April 23, 2022, the final form amendments to **Chapter 49**: **Certification of Professional Personnel** became effective upon

publication in the *Pennsylvania Bulletin*. Chapter 49 sets forth requirements for educator preparation, certification, induction and ongoing professional education.

The Bureau of School Leadership and Teacher Quality within the Office of Postsecondary and Higher Education at the Pennsylvania Department of Education has created a <u>Chapter 49 Implementation</u> and Updates page that will serve as a central location for news and announcements.

This page will be updated as more information becomes available."
