

### **Advocacy for our Future Educators**

This spring, you have two options to consider for participating in organized events intended to raise awareness about the issues that impact our work.

- 1. Advocacy Week April 8-11 (in collaboration with Pa CASE and PEDC)
- 2. Capitol Day May 6 (in collaboration with #PA Needs Teachers Coalition

PAC-TE is collaborating for the second year with Pa CASE and PEDC for an Advocacy Day at the State Capitol. This year, that date is Tuesday, April 8, with opportunities to visit your representative(s) and attend a noon press conference in the Main Rotunda. New this year is an additional emphasis on local meet-ups in the home districts afterwards.

As partners with Teach Plus in the #PA Needs Teachers Coalition, you have an **additional opportunity** to participate in a Capitol Day on Tuesday, May 6. Much like the April event, this includes a noontime press conference and individual meetings with legislators. Unlike the first event, it falls during the waning days of the spring semester. Yet, the

coalition is broader and the nearness to the state's budget deadline may elevate the energy level.

Governor Shapiro outlined his budget priorities on Tuesday, February 4, which including a large increase in expenditures related to public education. We know the increase makes for a robust debate within the legislature, not to mention at home. PAC-TE urges you to do the following:

- Discover the details of the governor's budget message here
- Discuss the issues in order to sharpen your understanding and the justifications for supporting a robust investment in education
- Decide which of the advocacy events you can attend
- Describe the goals and opportunities for advocacy with your students and encourage their attendance. Legislators respond to the stories our students share pertaining to their financial and opportunity struggles. To be impactful, we need you to invite student teachers who filled out the student teacher stipend application—those who received the stipend and those who were not awarded the stipend, as well as those who plan to student teach in 2025-26.
- Develop a clear and concise position on the relevant issues to share when a legislator asks, "What do you want me/us to do?"

I am reaching out today to assure you that the Pennsylvania Department of Education (PDE) is closely monitoring the orders and guidance being issued by the incoming federal administration. The Department is continually reviewing the guidance being issued and rescinded in real time and, to the

extent possible, is consulting with colleagues at the federal and state levels to determine the potential impact on Pennsylvania schools.

As ever, we will continue our work to ensure our schools and educators can continue to provide a world-class education to learners, and our libraries remain strong community centers.
