PAC-TE membership renewals occur yearly at this time. If your membership is through your college/university, ask your department leader to renew its Institutional Membership with PAC-TE at https://www.pac-te.org/i4a/pages/index.cfm?pageid=3284.

If you have an Individual Membership, e.g. Retired, Student, or you are an individual who is not covered by an institutional membership, you can renew your Individual Membership at the Individual Membership page. Dues remain the same for next year as they have for the past several years and entitle you to substantial discounts for our two yearly conferences.

PDE Information from Carissa Pokorny-Golden

The Director of the Bureau that oversees certification and teacher preparation issued announcements on May 24 and on June 14. If you did not receive a copy through your college/university email, the key points included the following:

• Individuals employed as social workers in schools, in accordance with CSPG #201, who have not yet obtained a School Social Worker Certification from the Pennsylvania Department of Education now have until August 1, 2026 to earn their certification by meeting the license and experience provisions outlined in the Special Considerations section of CSPG #87 School Social Worker, Educational Specialist Certificate PK-12. By the way, if you are unfamiliar with the aacronym CSPG, those are the policies that enumerate the PK-12 school positions that are

governed by certification--essentially they are the school leaders' rulebook as to "who" is permitted to teach "what". PDE wants to provide PAC-TE members an exclusive webinar just for us, so that they can explain several new updates to the set of CSPG's. If you have never heard of these, or if you are curious, or if you need an opportunity to ask questions about these policies, mark your calendars for August 3. Additional details will be sent to you in the coming days.

- Certification Services has brought on four new evaluators to process Instructional I and II certifications, as well as 3 new clerks to answer emails, phone calls, and documents sent by mail.
- Thanks to a question put to PDE by a PAC-TE member, PDE is now ready to approve Act 48 hours to mentors of school counselors, school nurses, school psychologists, and school social workers. Certain requirements exist.

Applications are available now for the 2023-2024 PA Education Policy Fellowship Program.

The Education Policy Fellowship Program is sponsored in Pennsylvania by The Education Policy and Leadership Center (EPLC).
